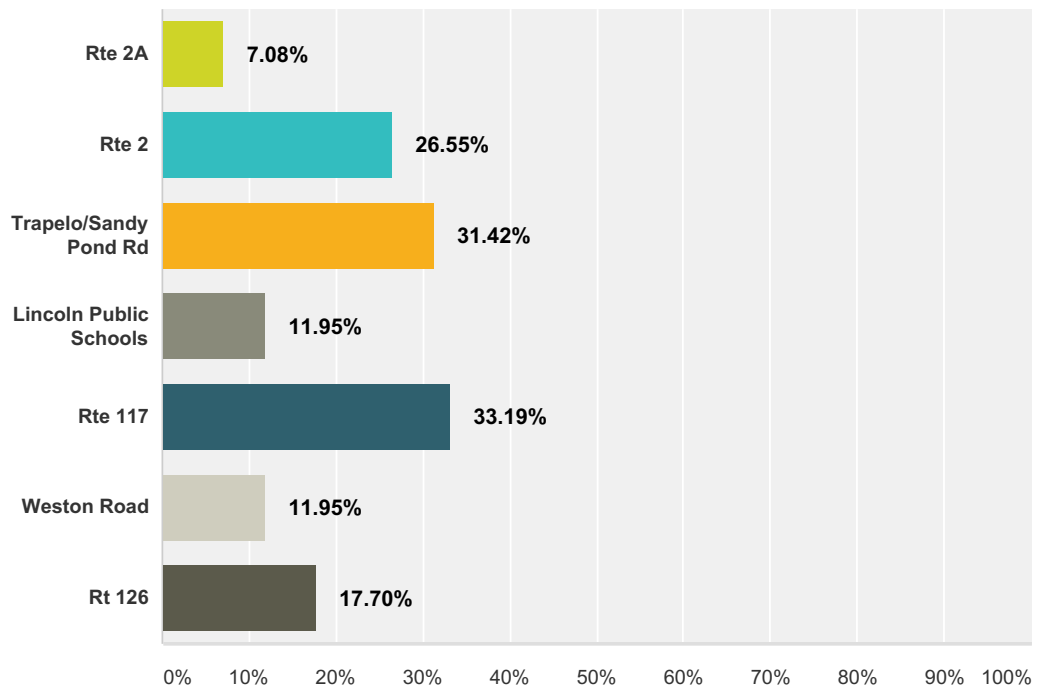


Q1 Please indicate which is closest to your home or work. (Please select up to 2)

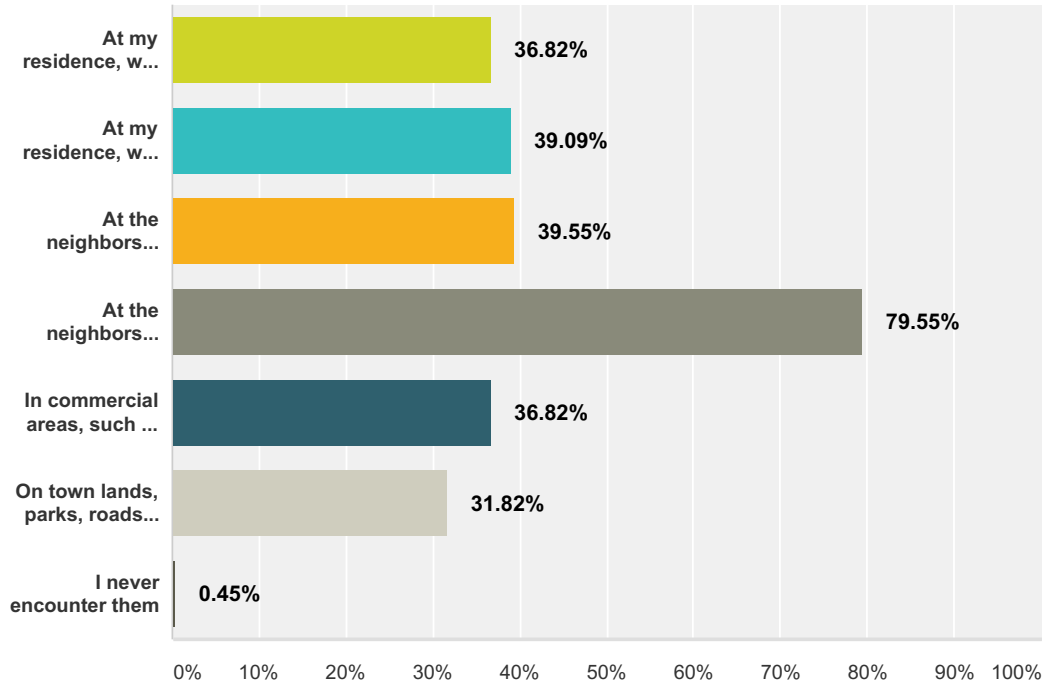

Q2 In what circumstances do you experience leaf blowers in Lincoln? (Please select all that apply)

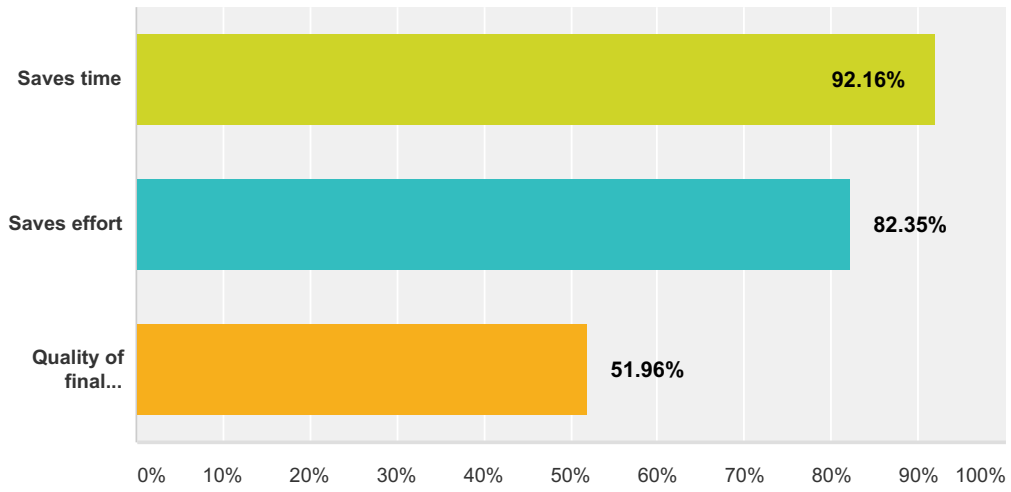

Q3 If you use a leaf blower, what are the reasons? (Please select all that apply)

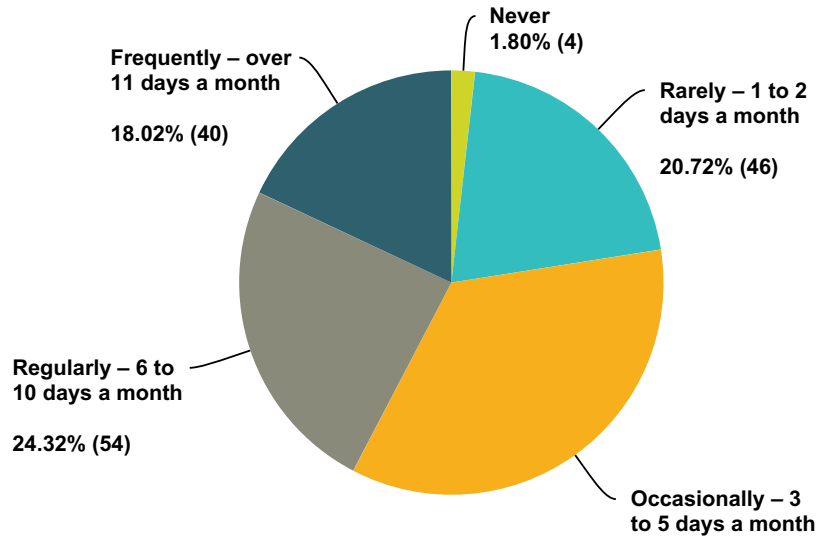

Q4 Between March and December, how often are you exposed (within hearing range) to leaf blowers in operation in Lincoln? (Please select one)

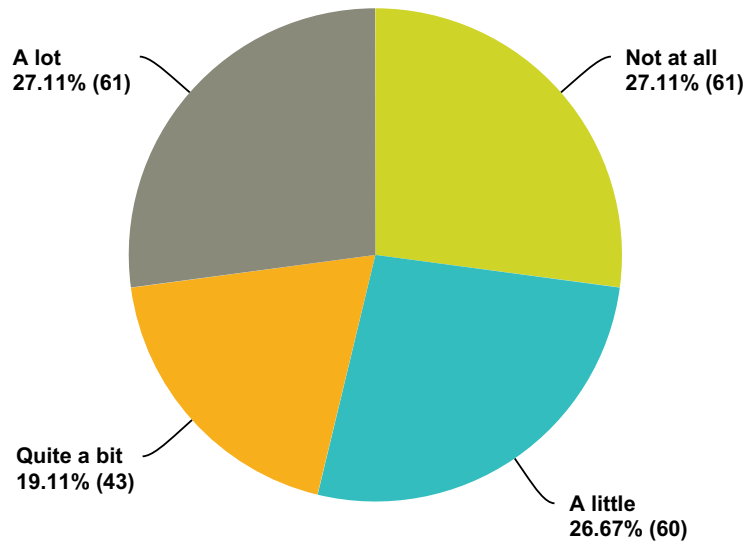

Q5 How much does leaf blower noise bother you?

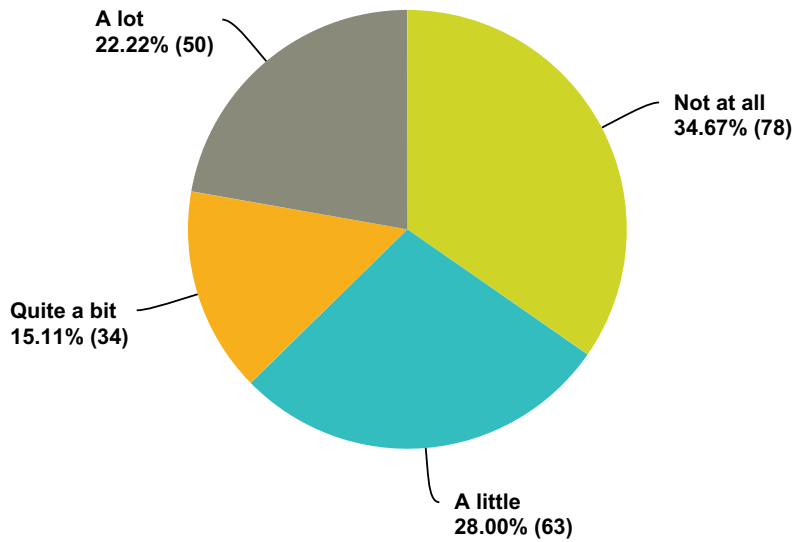

Q6 How much does leaf blower air pollution (gas emissions, dust) bother you?

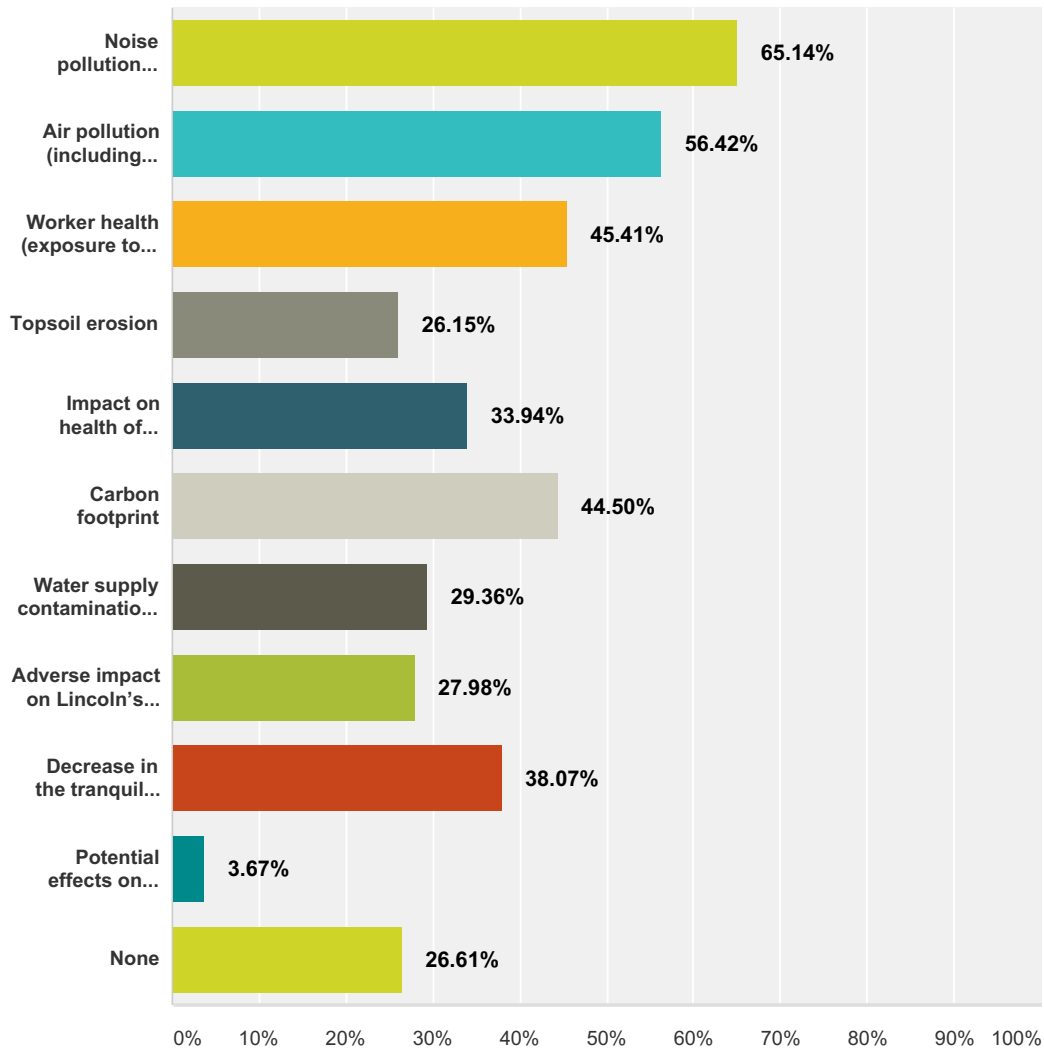

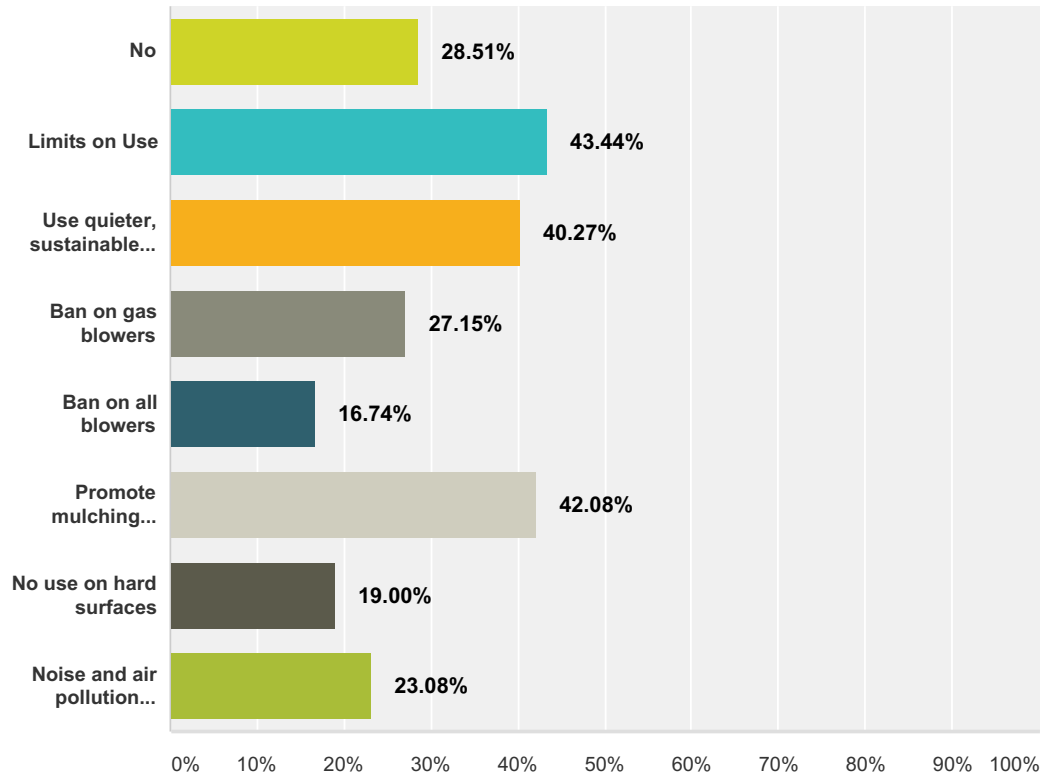
